There is no charge for these exhibits. Late entries may be accepted if space allows.

- 3. Although the 4 and 8 page exhibits and full-frame non-competitive exhibits will not be judged, a Wisconsin Federation judge will be available to critique the exhibit and offer suggestions regarding how to improve and expand the exhibit to a competitive level if the exhibitor so desires.
- 4. Late entries may be accepted if space allows. In case exhibit space is exhausted, late entries will be returned immediately. The Exhibition Committee reserves the right to accept or reject entries for any reason.
 - 5. Exhibitors will be notified of where and when to send exhibits to be submitted by mail.
- 6. Personally delivered exhibits will be received by the Exhibition Committee at the Exhibition on September 23, 2010. Exhibitors will be notified of when that day to deliver their exhibits for mounting.
- 7. Those personally calling for exhibits may receive them on Sunday, September 26, 2010, after the show closes. No exhibit will be removed until the exhibit area is cleared of all visitors.
- 8. OWNERS MUST PROVIDE THEIR OWN INSURANCE. All reasonable precautions will be taken for the safety of the exhibits. However, no responsibility shall attach to MILCOPEX, the hotel and convention center, or their officers, members, employees or volunteers for any loss or damage whatsoever.
